



### *Additional 2020 - 2021 Class Protocols*

#### **Registration and Payment**

- Class enrollment is limited this year for social distancing. Enrollment is available on a first-come, first-serve basis.
- All students must pre-register for workshops & classes. No daily drop-ins will be allowed.
- In the case of a dancer being denied access to a workshop or class due to symptoms compatible with COVID-19, parents can request a refund or credit for the pro-rated amount of their enrollment fee for services not rendered.
- In the case of an entire workshop or class closure due to COVID-19 related illness, parents will receive a refund or credit for the pro-rated amount of their enrollment fee for services not rendered.
- Should a teacher become ill due to a COVID related illness and classes need to be cancelled or postponed due to lack of available substitutes, registrants will be contacted. We will do our best to cover classes, but cannot guarantee the class can continue.

#### **Minimizing virus transmission through physical distancing**

- Dancers are grouped for the entire length of the session of classes with 15 or less students to minimize virus transmission. Faculty and dancers are required to wear face masks entering and exiting the building and when using the bathroom or when traveling through common space in the Community Campus. You are required to provide your own mask, but if needed we can provide a mask.
- Dancers **MUST** arrive to their workshop or class with their dance attire already on, cover-up over. Dressing rooms are not available.

- If needed for a workshop or class, each dancer will be given their own art supplies and books that will not be transferred between dancers.
- Parents are asked to limit their child's social interactions in non-class hours to help decrease exposure to the virus outside of classes.
- No water fountains will be used during classes. Dancers will be required to bring their own clean, labeled water bottle (minimum of 12 oz.) each day, can be refilled near the studio.

### **Drop off & Pick up Procedures**

- Parents are not allowed inside any Footlight studio to drop-off or pick-up their child(ren).
- Curbside drop-off and pick-up will occur outside the SW entrance of the Community Campus next to the Dance Studio, at the North doors of the YMCA, at the East door of Studio Move with the exit at the West door of Studio Move, at the South door of the Grange Hall with the exit out the East door of the Grange.
- Drop-off will be available 15 minutes prior to a workshop or class starting. Dancer drop-offs or pick-ups outside of this timeframe are discouraged as a separate individual screening needs to be done. Pick-up is the same, 15 minutes following a workshop or class ending.
- Ideally, the same parent or designated person should drop-off and pick-up the child every day. Car pools are not encouraged at this time.
- At drop-off, dancers will be screened for symptoms compatible with COVID-19. (100.4<sup>0</sup> or above). Parents will be asked to be on the alert for signs of illness in their children and to keep them home when they are sick.

### **Intensified cleaning and disinfection efforts**

- Hand hygiene stations will be set up at the entrance of each facility. Dancers are required to clean their hands prior to entering the building. If a sink with soap and water is not available, we will provide hand sanitizer with at least 60% alcohol.
- Dancers and faculty will be required to wash hands or use hand sanitizer before allowing participation, directly after participation, before and after snack/lunch, and after touching shared surfaces.
- An intensified cleaning and disinfecting routine will be implemented in concert with the Blaine County School District (BCSD), YMCA, Studio Move and Grange Hall custodial staff to include

frequent disinfecting of shared equipment and high touched surfaces throughout the day and supervised bathroom use to monitor proper hand-washing technique. Every evening after class hours, BCSD, YMCA, Studio Move and Grange Hall custodial staff will disinfect all meeting and common spaces including frequently touched surfaces.

## COVID – 19 Classes 2020 & 2021

### Footlight Dance Centre

As a parent and/or guardian of a child attending FDC 2020 - 2021 workshops/classes, I agree to abide by and follow these additional COVID-19 specific protocols as outlined below to help decrease the spread of virus transmission including the following:

- I will be alert for signs of illness in my child and I will keep them home when they are sick. I will provide them with a mask to enter, exit the building and use the bathroom.
- I will not be allowed inside any studio to drop-off or pick-up my child.
- I will drop off my child : SW entrance of the Community Campus, South entrance at the Grange Hall and East entrance for pick up, East entrance at Studio Move and West entrance for pick up, North entrance at the YMCA.
- I will make sure my child is dressed for the dance activity prior to dropping off.
- I will limit my child's social interactions in the evening non-class hours to help decrease exposure to the virus outside of classes and try to limit use of car pools if possible.
- I will provide a clean and filled water bottle (minimum of 12 ounces) each class for my child.
